4. Fundraising

a. DGIA Grant for concrete floor

Request to RDEK for concrete floor for storage building was accepted. We applied for 3900.00 and received a cheque for 1950.00 in September. (Since we applied through the Lions as our sponsor, the cheque was sent to them and they turned it over to us.) The remainder will be held by RDEK and reimbursed to us as we use the funds.

Since we received 1950.00 of the 3900.00 and spent 2619.94, Kathy has submitted a bill to the RDEK for 669.94. They will send a cheque to the Lions who will then reimburse us for that amount.

Businesses that contributed to this project: Mike Reimer, Catamount Contracting, Salvador Ready Mix, Gord Ward. We also received a hose and supplies donation from Mike Effry at Strategic. Thank you to Mike and volunteer Cleve Koswan for helping to prepare the site, and to Lyle and Bill for applying the floor sealer.

At this point, we have come in under budget by \$1280.06. Mike will buy grass seed for landscaping. Ask RDEK if we can use the leftover \$ for something else. Some of our other needs are: heavy duty shelving, flashlights, fire extinguisher, modifications to welding on trailer for water cans. Start by asking Jane if we could spend it on something else, then ask RDEK.

b. FireSmart Canada 2022 application

Applications for \$500 grant are open between Nov 1 2021 and Jan 31st 2022. We have to hold an event between May 7 and October 31st, 2022. The official Wildfire Community Preparedness Day is May 7 but we can hold an event anytime after until October 31st. Our application will say May 7 2022/

c. Columbia Basin Trust FireSmart Demonstration Lot

As reported at last meeting, we received 2500.00 from CBT for kiosk and educational signage. Our initial application was for a full 3 year project to the tune of \$25,000.00 but CBT changed the parameters. In order to complete the development of the FireSmart Demo lot as we had planned, we have to reapply for more money by Dec 2, 2021. Keeping the same goals and activities as already discussed, Kathy will adapt the new application in line with the new CBT funding program.

KIOSK

We paid a 1500.00 deposit to Hdw store for kiosk. Ch#44. Sono tubes are installed and we await the rest.

5. OPERATIONS AND EQUIPMENT

Equipment has been put away for the winter and operations have ceased since October 15. Start up plans for next year: meet in March and have equipment ready for action by April 15. See above for ideas re other supplies that we hope could be taken from DGIA funding.

6. WASP Summary

Kathy ordered 10 kits on July 22 which did not arrive until late August. Kathy paid for them with her personal MC \$1400.00 for which she was reimbursed with ch# 46 on Nov 10.

Sales Summary: Ray Hillman, Sharon Prinz, Dawn Marchi, Caroline Kelly, & Jim Crossley paid by etransfer to Kathy's bank acct which she reimbursed to us with ch#03 for 950.00. Mike and Kathy bought a kit for which they paid by ch#39. Anne Miguel and Shawna Jiminez each bought a kit for which they paid cash. This money was all deposited in our bank account on Nov 10 Deposit #13. We have 2 kits still unsold.

7. Community Recognition Program

We fulfilled our obligations for 2021 and Kathy will file the application by the Dec 31st deadline.

8. Forest Fire Hazard on Crown Land around Wasa

Mike talked to BC Timber Sales, Nature Trust, BC Parks. CBT has a new funding program re Wildfire Risk Reduction on crown land around communities. However, funding is only for 10-15 hectare parcels and ours is much bigger.

Terry Balan has recently informed us about a new group, East Kootenay FireSmart Team, who are working on some new initiatives on crown land. We await further news about this but in the meantime, we will not be pursuing a proposal for crown land treatment.

9. OTHER BUSINESS

- Nexus Security system Kathy contacted Wolfgang yesterday who said someone will be able to meet with us next week.
- Do we want to look more into society or association status? No, the only real advantage to becoming a society is that we could apply for funding on our own but we can continue to go thru Lions to sponsor us for grants.
